YMCA Code of Conduct

The YMCA of Metro North is committed to providing a safe and welcoming environment for all. For the safety and comfort of those who are in our facility, participating in our programs, or on our grounds, we ask individuals to act in a manner that upholds our guiding principles of honesty, responsibility, caring, and respect at all times. Guest privileges and Nationwide reciprocity have been suspended at this time.

- We expect persons using the YMCA to behave in a mature and responsible way and to respect the rights and dignity of everyone regardless of race, ethnicity, age, religious beliefs, national origin, gender identity, sexual orientation, or physical abilities.
- Our Code of Conduct does not permit language or any action that can hurt or frighten another person, or that falls below a generally accepted standard of conduct.
- Members and guests are encouraged to be responsible for their personal comfort and safety. If
 a member or guest feels uncomfortable in confronting a person directly, they should report the
 behavior to a staff person or the Building Supervisor on duty.
- In order to carry out these policies, we require that members and guests identify themselves to staff when asked. Members must scan into the facility with a YMCA-issued key tag or code.

Prohibited actions specifically include, but are not limited to:

- Cell phone use and picture taking are not permitted in locker rooms or program areas.
- Bringing non-members into the YMCA without following established guest procedures is prohibited.
- Inappropriate attire; including clothes with vulgar or profane language, symbols or gestures.
- Harassment, vulgarity, or intimidation by words, body language, or behavior.
- Physical contact or threatening behavior and any other conduct of an inappropriate, threatening, or offensive nature.
- Theft or behavior that results in the destruction of property is prohibited.
- Carrying or concealing weapons, or objects that may be used as weapons is prohibited.
- We prohibit use or possession of illegal chemicals or alcohol on Y property, vehicles, or at Y sponsored programs.
- Smoking is not permitted in or outside the YMCA.

Sex Offender Registry

• The YMCA conducts regular sex offender screenings on all members, participants, and guests.

If a sex offender match occurs, the YMCA reserves the right to cancel membership, end program participation, and remove visitation access.

Requirements for personal safety and social distancing

- Forehead thermometer temperature scans and health check questionnaire acknowledgment may be required of all individuals prior to entering the facility.
- When required by State guidelines, all members will be required to wear masks while entering the facility and in common areas and may be required to wear masks during group fitness activities and on the fitness floor.
- For your protection, cleaning supplies are available for you to sanitize equipment before and after your use.
- Maintain a distance of no less than 6 feet from other individuals at all times.
- Congregating in small groups under 5 people is allowed as long as traffic flow is not impeded.
- Sweat towels, water bottles, and other personal belongings must be kept with you at all times.
- Stay home if you feel sick or have a temperature in excess of 100.4 degrees.

The Branch Executive Director will investigate all reported incidents. Suspension or termination of YMCA membership, program participation and/or facility access may result if there is a violation of the YMCA Code of Conduct. Members must acknowledge their acceptance of this Code of Conduct before entering a YMCA facility.

Participant Release & Waiver of Liability and Indemnity Agreement Assumption of Risk

I acknowledge and agree that any use of YMCA OF METRO NORTH facilities, services, equipment and premises("Facilities") and any participation in YMCA OF METRO NORTH programs and activities ("Programs") comes with inherent risks including, but in no way limited to: (1) moderate and severe personal injury, (2) property damage, (3) disability, (4) death, and (5) sickness or disease. I voluntarily accept and assume full responsibility for these risks as well as any and all other risks of the use of Facilities and participation in Programs. I agree that I have full knowledge of the nature and extent of all such risks and am not relying on all such risks being described in this document.

Waiver, Release, Indemnification & Covenant Not to Sue

In consideration of the use of Facilities and participation in Programs I, the undersigned, agree that YMCA OF METRO NORTH it's officers, directors, agents, employees, volunteers, insurers and representatives ("Releasees") will not be liable for any personal injury, property damage, disability, death, sickness or disease incurred by myself, my family members, dependents, or guests, including minors, however occurring including, but not limited to the negligence of Releasees. I understand that I will be solely responsible for any loss or damage, including personal injury, property damage, disability, death, sickness or disease sustained from the use of Facilities and participation in Programs.

I further agree, on behalf of myself and any and all legal successors and proxies, to release and hereby do release, waive and covenant not to sue Releasees from any causes of action, claims, suits, liabilities or demands of any nature whatsoever including, but in no way limited to, claims of negligence, which I and any and all legal successors and proxies may have, now or in the future, against Releasees on account of personal injury, property damage, disability, death, sickness, diseases or accident of any kind, arising out of or in any way related to the use of Facilities or participation in Programs, whether that participation is supervised or unsupervised, however the injury or damage occurs, including, but not limited to the negligence of Releasees.

In further consideration of the use of Facilities and participation in Programs, I agree to indemnify and hold harmless. Releasees from any and all causes of action, claims, demands, losses, suits, liabilities or costs of any nature, whatsoever, including claims of negligence, arising out of or in any way related to the use of Facilities, and participation in Programs by myself, my family members, dependents or guests, including any minors. This is an insurance company required waiver. This document effects your legal rights and is legally binding. By signing this agreement, you are releasing the YMCA of Metro North from all liability and forever giving up any claims therefore.

TEEN CENTER CODE OF CONDUCT

All participants are required to follow the Y Teen Center Code of Conduct when visiting.

o Bullying (physical, verbal, or cyber) will not be tolerated

- o Students must respect the staff members, other participants, and space
- o Students are expected to clean up after themselves and leave the space better than they found it
 - o Students will take ownership of their actions and have respectful conversations with staff regarding any inappropriate behavior
 - o Students represent the Teen Center while signed in and will behave appropriately around other programs in the building
 - Students are expected to report conduct violations by participants and maintain open and honest communication with staff
 - Staff members have final say on all matters regarding safety of participants within the program

The Teen Center requires and considers the following mandatory:

- Observance of all written and verbal rules and regulations, including those deemed necessary/enforced by Teen Center staff

The Teen Center prohibits the following activities:

- 1. Use of foul language or profanity (including on clothing or belongings)
 - 2. Any act of violence intent
- 3. Vandalism or theft of any facility equipment and/or other participants' belongings
- 4. Behavior that violates state/local laws, and school/facility rules and regulations

 If these rules are broken, a conversation is required with the student and parents or

 guardians to determine necessary next steps.
